Now, the Council is pleased to accord Provisional Affiliation to the following two-year Diploma course in Pharmacy of your Institute for the Academic Session 2025-26.

However, this Council has observed following deficiencies/disputes during the inspection of your Institute.

1. A part of the leased building facility found to be used as motor vehicle service center
2. Temporary partition walls using aluminum channels & plywood found in four Laboratories & Machine Room
3. Sizes of the Laboratories found to be smaller than PCI norms, No working table made up of permanent concrete slabs found in the laboratories
4. Model Pharmacy, Museum, Machine Room, Store Room I & II not as per norms, Marked Aseptic Room not in working condition, Central Instruments Room not available
5. Less number of equipments found in the laboratories, some equipments found to be not installed
6. Inventory software for Retail Pharmacy not available

You are advised to comply above mentioned deficiency(ies) and submit a compliance report to the Council within three (03) months.

All norms and standards of PCI and WBSCT&VE&SD shall have to be fulfilled by your Institution. Conduct of regular offline classes (at least 6 days in a week) is a mandatory requirement for affiliation of the course. No online class is allowed. In case of any deviation from the above conditions this provisional affiliation shall stand cancelled without any prejudice.
